- If you hold UK or equivalent overseas degree in BA Accountancy or BA Accountancy and Finance or a relevant UK or overseas Business or Economics Degree with substantial modules in Accountancy (e.g. BCom from the University of Delhi, India)
- Anyone who already holds a CIMA Advanced Diploma in Management Accounting and now wishes to obtain a postgraduate university Masters academic qualification as well as complete accountancy professional training (especially if you did not take a graduate route and consequently do not hold a university bachelor's degree).
- It offers you the chance to enhance and focus your knowledge, skills and career prospects, as the combination of high-level professional and academic qualifications is a strong assertion of your tenacity, intellect and competence, and a highlight of your CV.

COURSE OVERVIEW

ENTRY REQUIREMENTS

The entry requirements for these courses include:

For the MSc Accountancy and Finance (ACCA Pathway):

- A good honours degree in accountancy, with ACCA accreditation for F1-F9,
- Or, ACCA Fundamental level papers F1-F9.

For the MSc Accountancy and Finance (CIMA Pathway):

- A good honours degree in accountancy, accountancy and finance, or a business related a degree with accountancy as a major.
- Or, CIMA Advanced Diploma in Management Accounting
- TAR College (Malaysia) Executive Development Programme for Direct Entry into the Postgraduate Diploma Stage

For the MSc Accountancy and Finance (Top-up):

- Any CCAB accounting professional qualifications (ACCA, CIPFA, ACIEW, ACAS, and ACAI). Or equivalent overseas qualifications which have been fully recognised by any of the CCAB members or the University (Certified Public Accountants of Singapore ICPAS, Hong Kong Institute of Certified Public Accountants HKICPA and Institute of Chartered Accountants of Australia ICA, which is also designated as CPA Australia).
- CIMA final stage examination completion and members.

All courses require an English Language qualification (for those where English is not your first language) of a minimum IELTS score of 6.5 average (minimum of 6.0 in all bands) or minimum TOEFL score of 575.
