It would normally take between three and four years to complete all of these papers. You can join the course at any stage depending upon your previous ACCA study and exemptions. (You are advised to confirm exemptions and eligibility directly with the ACCA).

You will be studying at a pace to match your own abilities and aspirations by selecting between four and six papers each year (at least two of these must be studied each term). Examinations are taken in either December or June each year.
