ENTRY REQUIREMENTS

At least 280 UCAS points obtained from a minimum of one 12-unit or two six-unit A Levels, plus at least five GCSEs at grade C or above, including English language and mathematics or equivalent qualification.

COURSE OVERVIEW

- This course offers the professionally-focused, practical study of accountancy, combined with a wide-ranging exploration of key contemporary business topics. You study a core first year, with other students studying business joint degrees before moving to subject-specific modules for the rest of your course you get flexibility of subject choice and increase your employability.
- The study of accountancy enables you to acquire the skills necessary for the preparation and, more importantly, the interpretation of financial statements. You will learn the basics of financial and management accounting, business taxation and corporate reporting.
- The study of business provides a detailed understanding of the way organisations work, how they operate within their specific environment and the impact on individuals working within them. This pathway develops a general knowledge of business to complement a more specialised area of study.
- Case studies look at the published results of real companies, and high profile guest speakers share experience and insight. You can also undertake a 'Dragons' Den'-style business plan to kick start your entrepreneurial thinking.
