#### 6 Module Overview

This is a compulsory Level 4 module. The module has been designed to align with aspects of the functioning legal knowledge assessments of the Solicitors Qualifying Exam, particularly relating to competence A5 which requires 'applying understanding, critical thinking and analysis to solve problems'. This module aims to furnish you with the key academic and scholarly skills to enable you to flourish as a legal scholar and critical thinker, and to succeed in your studies. The module provides core legal, academic and theoretical skills which will support your study of contract and tort law at Level 4, and in all compulsory and optional academic modules at Level 5 and Level 6.

Critical Legal Thinking is a module in which you will apply legal theory to think critically about law, its role in society, and our role within it. The approach of this module is to investigate and apply legal theory (jurisprudence) to societal issues. This theoretical introduction to the law requires philosophical reflection and critical engagement with questions of justice and morality. This module provides a macro level study of the law, providing students with the training necessary to look critically at the big picture and the context within which legal systems operate.

The overarching objective of this module is to equip you with the ability to think critically (about law, its role in society, and our role within it). You will learn to question orthodox ideas, justify your perspective, transcend taken-for-granted preconceptions, and apply different perspectives to sociolegal issues. You will use these skills throughout your entire degree where you must critically analyse the law. In studying different perspectives, you will develop your critical thinking skills by weighing up different perspectives on core features of law, and constructing academic legal arguments about law's nature, functions, and effects. You will explain and engage with theoretical arguments about justice and law by questioning, interpreting, synthesising, and analysing what you learn about the law.

The core transferable skills covered in this module are those of criticality and the application of critical thought in order to solve socio-legal problems, argument development, the use of legal theory and other legal sources in research, and the presentation of ideas in written academic form.

In particular the module will develop your skills in five critical areas of critical legal thinking in order to empower you in all your subsequent areas of legal study:

- 1. Critical engagement (reading, thinking, writing, analysis) with theoretical legal materials
- 2. Critical application of legal theory to solve theoretical dilemmas
- 3. Reading skills required to tackle legal theory, academic legal texts, and primary legal sources (legislation, cases, etc)
- 4. Legal research skills including referencing and complying with academic integrity standards
- 5. Legal reasoning, thought and creativity applies to address issues of justice, morality and equality



The module is also aligned to the University's Graduate+ award programme that enables you to develop your experience and build your skills, enhancing your employment options when you leave University, and will contribute to the achievement of the Bronze Grad+ by developing your employability skills with specific focus on Organisational & Time-management Skills; Written Communication Skills; Research skills; and Independence & Reflection.

Assessment in this module is by way of a piece of coursework in the form of an essay.

- (c) Argument development in a legal theoretical context

#### 6 Module Overview

This is a compulsory module. The module aims to provide you with foundational skills to equip you for your future study in law and also your future personal and career development. You will explore some of the foundational transferable skills that are needed in order to successfully study the law, as well as starting a reflective process preparing you for a future legal or other career. The module provides foundational knowledge to support your study in Professional Skills at Level 5 by starting your learning in a range of professional skills such as time management, independent learning and reflection. These skills are explored through the development of other core skills such as legal research, writing and advocacy. Since it is vitally important that you begin your career reflection and management early, you will also start to think about your own career development and this will be taken further in Professional Skills at level 5.

This module supports the course ethos by fostering the development of your autonomy by starting to get you to work independently. You will also take part in a rich, diverse and inclusive learning environment by working collaboratively in workshops and learning how to develop your own assessment and feedback literacy. You will build your own scholarly and personal development by starting the process of thinking about your own transferable skills, which will be further developed in Professional Skills at level 5. As a result of this reflective process, you will build your belief in your own abilities and this will help you to develop resilience in dealing with future challenge. Finally, the module supports the course ethos by enabling you to develop your transferable employability skills, principally your time management and personal organisation skills to ensure you can solve legal problems using legal sources effectively in a timely and collaborative way. The module also fosters your ability to work independently and to reflect on your progress. These transferable skills are embedded within the content of the module. The module is also aligned to the university's Graduate+ award programme which enables you to develop your experience and build your skills, enhancing your employment options when you leave University. As part of the module you will be expected to begin to engage with the Bronze award. This will then be developed to Silver award at level 5 in Professional Skills and to Gold award at level 6 in your 40 credit module.

Assessment in this module is by way of a piece of coursework in the form of a problem scenario and a presentation reflecting on your skills development in the context of possible career paths.

#### 7 Indicative Content

This module is built around the core skills necessary to the practice of law or a professional career in law-adjacent fields. The module content follows four themes: Theme one is legal research. Theme two is writing. Theme three is public speaking and advocacy. Theme four is professional practice (career building skills). These themes enhance the development of the following skills

- 1. Personal development skills:

- (b)personal organisation and time management:
- (c) academic and personal reflection;
- (d) assessment and feedback literacy;



- (e) independent learning and personal autonomy; and
- (f) confidence building.

#### 5 Module Overview

This is a compulsory Level 4 module. The module has been designed to align with aspects of the functioning legal knowledge of the Solicitors Qualifying Exam.

The module aims to provide you with basic knowledge of what the law is, what are its sources and the main characteristics of UK and foreign legal systems.

The module provides foundational knowledge to support your study in Contract Law & Tort Law at Level 4, Criminal Law and Constitutional & Administrative Law at Level 5, Law of the European Union and the optional Comparative Constitutional Models module at Level 6 by providing you with foundational concepts to be developed further in these modules.

This module will foster the development of your autonomy and your professional and ethical attributes by inviting you to reflect on the structure of the legal system, the role of the judiciary and the role of lawyers. You will develop your creative and independent thinking and you will be invited to reflect upon important issues such as diversity in the legal profession that will inform the development of your ethos and moral values. Learning, teaching, assessment and feedback within the module will involve opportunities for in-class debate, group discussions and the possibility to share ideas with your peers. The development of your research skills will inform your scholarly and personal development by providing you with the means to form your own ideas and empower your belief in your own ability, thereby enabling you to persevere when encountering challenge. You will develop your writing and research skills and your decision-making skills as you use logical reasoning in order to make valid, reasoned choices. These transferable skills are embedded within the content of the module.

The module is also aligned to the university's Graduate+ award programme that enables you to develop your experience and build your skills, enhancing your employment options when you leave University and will contribute to the achievement of the Bronze Grad+ by developing your employability skills focussing specifically upon team-working, oral and written communication, self-awareness and IT/computer

#### 5 Module Overview

This is a compulsory level 5 module.

The module aims to providing you with an opportunity to develop certain transferable skills, principally oral skills, but also written skills and professional ethics. Workshops will take place in dedicated courtroom space to foster a professional approach. The module builds on what you have already learned in Foundations in Professional Skills at Level 4 by developing your confidence further through the practice of oral and written skills, and by recognition of the need for resilience and emotional intelligence. The module also acts as a preparation for clinical placement modules studied later at Levels 5 and 6 by equipping you with oral, written and ethical awareness.

By fostering the development of your autonomy by designing activities for you to work on collaboratively outside class in your Action Learning Sets. You will take part in a rich, diverse and inclusive learning, teaching, assessment and feedback experience by means of simulated practice-based learning, tailored audio-visual feedback and in the completion of your personalised career planning assessment. You will build your scholarly and personal development through a model of support and challenge as you practise some of the skills encountered in legal practice. While more will be expected of you than at Level 4 of your studies, this challenge will take place in a supportive and diagnostic environment. By treating you as a budding professional in your skills practices and by challenging you to persevere in the face of difficulty whilst taking responsibility for building your own levels of resilience, this module will enable you to persevere when encountering challenge.

A major thrust of this module will be to help you develop certain transferable skills, principally oral skills, but also some written skills and "softer" skills such as autonomy, resilience and reflection which allow you to develop throughout the course as you spiral up through your curriculum. These transferable skills are embedded within the content of the module. The module is also aligned to the university's **Graduate+** award programme which enables you to develop your experience and build your skills, enhancing your employment options when you leave University. The module will enable you to engage in career development planning to support your employability, via the completion of a detailed career portfolio linked to the Silver Graduate + award.

#### 5 Module Overview

This is a compulsory module which has been designed to align with aspects of the functioning legal knowledge of the Solicitors Qualifying Exam.

The module aims to provide you with an understanding of the legal principles and rules involved in land law and an introduction to property transactions (also known as conveyancing). You will consider how they operate in the wider social and economic context and the legal ethics of property transactions.

The module builds on the transferable skills that you developed in Professional Skills and Critical Thinking at Level 4 by developing the skills acquired .The module also provides foundational knowledge to support your study in the optional module Advanced Property.

You will be carry out your own research into the current law in order to consider past and likely future developments and how changes are shaped by society and the wider world. You will consider conflicting interests of parties and the position of professional advisers. Land Law and Property Practice will enable you to engage with the theory of land law alongside an introduction to practical and procedural matters to bring the subject to life. You will consider real life scenarios in workshops which will encourage the development of your increasingly enquiring mind. You will advise upon land law related issues, whilst also developing your professional and ethical awareness continuing the realistic problems that pervade the module.

The transferrable skills of independent research, problem solving, ethical awareness and effective written communication, are embedded within the module.

The module is also aligned to the university's Graduate+ award programme that enables you to develop your experience and build your skills, enhancing your employment options when you leave University and will contribute towards your progress the achieve the Graduate + Silver award. With its focus upon realistic problems taken from legal practice the module will make a contribution to your professional development and to becoming work ready.

#### 5 Module Overview

Constitutional and Administrative Law is a core module which has been designed to align with aspects of the functioning legal knowledge of the Solicitors Qualifying Exam.

Building on the knowledge of British political and legal institutions that you acquired in Legal Systems at Level 4, this module will allow you to explore the UK constitutional framework in greater depth, and key constitutional principles that underpin British democracy. You will develop a critical understanding of those UK constitutional institutions and you will also conduct research into the impact of Brexit on the sovereignty of the UK Parliament and Constitution. Judicial and non-court based mechanisms of control of governmental action, such as judicial review and Parliamentary Ombudsman, will be considered and you will critically assess the case-law that forms the basis of the unwritten British constitution.

You will study this module in the midst of the fundamental legal and political change. To help you to understand the rapidly evolving legal context, the module will place particular emphasis on the transferrable skill of legal research and written communication as you develop the ability to navigate your way through complex sources of constitutional law, while making effective use of your time and the academic resources available. By summarising your findings clearly and concisely, you will further improve your resilience and adaptability. You will develop your technological literacy and teamwork skills.

The module is aligned to the university's Graduate+ award programme that enables you to develop your experience and build your skills, enhancing your employment options when you leave University and will contribute towards your progress the achieve the Graduate + Silver award. With its focus upon current issues and realistic scenarios taken from legal practice the module will make a contribution to your professional development and to becoming work ready.

#### 6 Module Overview

This is a compulsory module and is part of all LLB pathways which has been designed to align with aspects of the functioning legal knowledge of the Solicitors Qualifying Exam. The module aims to introduce the concept of equity and how it interacts with the law to create the trust by building on what you have learned in Contract Law and Land Law at Levels 4 and 5 about equitable remedies and property ownership.

This module will develop your ability to undertake independent research while critically analysing the way in which the law applies to real life scenarios. It will do this by incorporating a rich, diverse and inclusive learning environment which draws upon the knowledge which you have already gained and challenging your understanding through group work and interactive materials taking a student-led approach. The assessments will further challenge your ability to conduct independent research and critically analyse the application of the law as well as preparing for SQE 1 style assessments. The module will support your personal development in taking on these challenges by using a wide range of feedback techniques which will improve your confidence in your own ability and help to build resilience to challenges. Equity and Trusts will also provide you with a range of transferrable skills such as researching, problem solving and team work which are essential both within and outside of practice. These transferable skills are embedded within the content of the module.

#### 5 Module Overview

This is a compulsory module on all pathways of the LLB Course.

The module has been designed to align with aspects of the functioning legal knowledge of the Solicitors Qualifying Exam, in particular in the 'Legal System' section of the SQE syllabus.

The module aims to familiarise you with the Law of the European Union, combining the study of theoretical and practical elements and the procedural and substantive foundations. The module examines and evaluates the structural organisation of the EU and the way its legal processes operate. This module contextualises the rules that derive from Europe within the legal institutional framework and also the way in which those rules affect business and wider society.

The module builds on what you have learned in Legal Systems at Level 4 and Constitutional & Administrative Law at Level 5 as it relates to the relationship between the structure of the EU and the English legal system, taking into account the UK's status as a Third Party Country under EU Law.

This module therefore develops your understanding of legal systems in the international context and expands your understanding developed through the above two modules. This module will foster the development of your autonomy and ethical attributes, as well as your ability to exercise judgment and think on your feet through the practical, presentation-based assessment in this module. It will also encourage your academic success by allowing you to develop your transferable skills in the practical, applied approach to teaching and learning in this module. It will also enable you to develop yourself personally and academically through the way that this module links to subjects studied, and assessment methods used earlier in the course, further challenging you to develop academically at a higher level, and in an international law context. This assessment also challenges you to develop resilience. This module will also enable you to develop the following skills which are transferrable in legal and non-legal contexts: the ability to make oral presentations in an unfamiliar environment, and the ability to assimilate and critique information in a new field related to, but different from, areas you have already studied. These transferable skills are embedded within the content of the module.

The module is also aligned to the university's **Graduate+** award programme that enables you to develop your experience and build your skills, enhancing your employment options when you leave University. The Law of the European union module's content fosters a more global outlook by encouraging an international overview of the UK's position in relation to the EU as an international organisation.

#### 5 Module Overview

This is a core Level 7 20 credit module and one of the modules that must be successfully completed in order to qualify for the LLM in International Business Law pathway. It considers the role of corporate structures and their global operations, and how these may lead to fraud, corruption and tax evasion. The role of intermediaries (such as banks, insurance companies, and law firms), tax havens, and tax evasion methods are considered in terms of how they may facilitate corporate criminality. The module will draw from case studies in various jurisdictions which offer an insight into such practices, as well as referring to the relevant law in applicable jurisdictions.

The module aims to provide an intellectually stimulating and academically rigorous education by critically evaluating how corporations may be involved in criminal conduct. It develops a critical understanding in this area through consideration of fraud, corruption, and tax evasion as well as the role of intermediaries and tax havens. You will gain an understanding of the existing legal framework of principles, concepts, and mechanisms, as well as develop an understanding of their limitations. By understanding and applying this legal framework you will develop the ability to critically appraise its scope and limitations, and the ability to exercise good judgment in selecting and using primary and secondary sources for research.

This module will be delivered through face-to-face teaching and VLE provision. On campus students will attend weekly student-led/tutor facilitated seminars and complete various activities. Distance learning students will complete weekly VLE activities.

#### 5 Module Overview
